Our state-wide membership includes 79% of Utah's Local Governments: 91% of Utah's Cities and Towns, 75% of Utah's Local and Special Service Districts, and 34% of Utah's Counties.

The Trust protects \$6.7 billion in member assets and hundreds of millions in liability risks. In 2021 alone, the Trust paid more than \$18.7 million in claims and operating expenses, while still strengthening member security by \$6.3 million. This added security protects members from the uncertain storms of tomorrow.

More than 85% of governmental entities nationwide partner with risk pools, because risk pools understand their unique needs and challenges, and because the pools themselves are governmental entities with no profit motive. Even among government risk pools, the Trust is unique. The Trust leverages its size, scale, efficiencies and strategic partnerships to benefit members even better than other pools. It's the law of large numbers and disciplined management that make this possible.



THE TRUST IS A TRANSPARENT GOVERNMENT ENTITY, FULLY ACCOUNTABLE TO ITS 558 MEMBERS. In 2021, the Utah Local Governments Trust welcomed 44 new members to our pooled programs. Not surprisingly, 99.8% of members renewed their partnership with the Trust. The Trust provides the coverage and low rates our members require, which is reflected in the enduring relationships we have with our members.

Our results are your results. In 2021 the Utah Local Governments Trust again delivered positive results, including: a 22% reduction in indemnity claims; a 26% reduction in loss adjustment expense, 47% reduction in premium tax, and a 20% reduction in general and administrative expenses. These savings provide the foundation for low rates, and returning money back to our members.
